

COVID-19 Update Statement – Stonebridge Health & Rehab 05.12.20

Caraday Healthcare is a leader in skilled nursing, delivering integrated and coordinated care along the long-term and post-acute care continuum.

Given the significant extent of the Coronavirus (also known as COVID-19) and the particular risk it poses to the elderly and compromised residents of Caraday's 13 centers in Texas, our leadership team has announced proactive plans to take every precautionary measure to ensure the safety of our residents and staff. We also will expand our role as a credible and reliable source of information for our patients, residents, families, employees, local health agencies, and the broader communities in which we operate because they are already reaching out to us with sometimes conflicting information.

On Friday we learned that a resident who was sent to the hospital with symptoms associated with Coronovirus has received a positive test result for COVID-19. We have tested all residents and team members and the results show that 24 residents and 11 team members had positive results. All of the residents whose tests were positive have been isolated to a separate unit as an additional precautionary measure. All effected team members are isolating at home.

We are following our pre-established protocols that include implementing immediate and precautionary steps to ensure we stop the spread of the infection within our community. Caraday is proactively working with public health agencies and medical providers and we are monitoring the situation very closely.

COVID-19 is an unprecedented challenge across the country, particularly for nursing homes caring for our nation's most vulnerable population. We continue to be inspired by our residents and the team members caring for them who so bravely rise to the challenge and support each other through this incredibly difficult time.

About our Protocol

Following guidelines issued by the U.S. Centers for Disease Control and Prevention (CDC), the World Health Organization (WHO), and the Centers for Medicare & Medicaid Services (CMS), as well as our own Infection Prevention and Control Program, we have implemented the following measures:

- We were and are very proactive in not permitting medically unnecessary visitors and restricting access to our communities since early March.
- In lieu of in-person visits, we are helping facilitate virtual communications and social connectedness between our residents and their families and friends.
- We continually conduct extensive and ongoing employee education on ensuring resident and personal protection, including extreme hand hygiene guidelines.
- We require the use of personal protective equipment.
- We perform extreme and continuous housekeeping using highly effective cleaning products for common viral infections.

We will also continue to actively communicate the steps Caraday is taking to protect all of our communities, as well as disseminate ongoing news and updates regarding COVID-19 and guidelines people can use to better protect themselves as a matter of course.
